## Pre-Approved Academic Programs

Our staff has been busy reviewing college and university programs as they work to meet the new MHRT/C knowledge competencies. The programs below are approved for full certification, effective Fall 2018:

### Central Maine Community College:

CMCC has received approval for their Associate's of Applied Science degree in Human Services.

### University of Maine at Augusta:

UMA has received approval for their Bachelor's degree in Mental Health and Human Services.

### York County Community College:

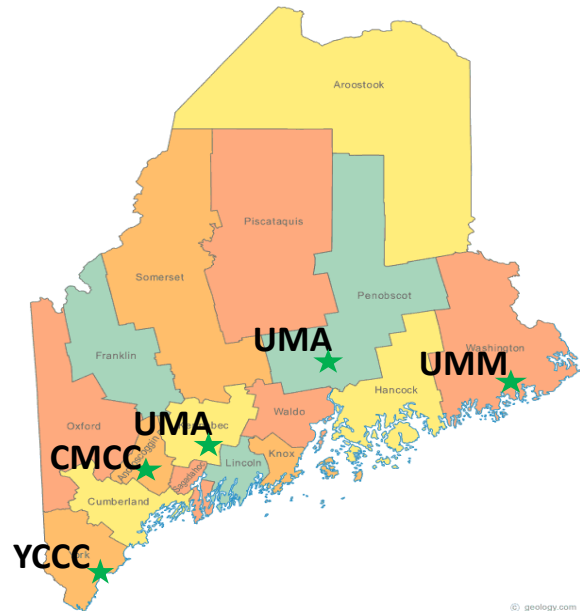
YCCC has received approval for their Associate's degree in Behavioral Health Studies. They also offer an approved, stand-alone MHRT/C certificate option.

To date, over **1,100** MHRT II, III, IV and C certificate holders have updated their contact information with us. Are you one of them? If not, please send complete home contact information and email address to: [updatemhrtccontactinfo@cfl-muskie.org](mailto:updatemhrtccontactinfo@cfl-muskie.org)

Has your name changed since your certificate was issued? If so, please also include documentation of your name change. We accept legible copies of the following:

- Marriage license
- Divorce settlement (We only need page 1 and the page listing your new name.)
- Court legal name change petition

To date, we have reissued over **850** certificates. Certificates are reissued based on the month your original certificate was issued. It is sent as a PDF to the email you provide us.

Have you already updated your contact information, and your month has come, but you haven't received your certificate? First, please check your spam trap. If it is not there, please contact us.

**REMINDER:** All MHRT II, III, IV and C certificates without an expiration date will become invalid on January 1, 2020.
