Individuals who have updated their contact information:

879 individuals with an MHRT II, III, IV or full MHRT/C certificate have contacted our office to update their personal contact information. If you hold one of these certificates and have not yet sent us your contact information (email and mailing address,) please submit it to the following email address: updatemhrtccontactinfo@cfl-muskie.org

If your name has changed since your original certificate was issued, please send us documentation of your name change such as a copy of your marriage license, your divorce settlement (page 1 and the page listing your new name), or court legal name change petition.

Reissued MHRT/C certificates with a two-year expiration date:

342 individuals have been reissued a new certificate so far this year. The new certificates have an expiration date in 2020. Of these, any original MHRT II, III or IV certificates have been reissued as MHRT/C's, ending any confusion as to whether or not they were equivalent to the MHRT/C (they were).

If you have updated your contact information, and your original certificate was issued during the months January through May, *and* you've not been reissued a new certificate, please notify Scott Bernier at sbernier@maine.edu.

If your original certificate was issued in June through December, your reissued certificate will be sent to you in that same month.
